Note: in 2019-2020 academic year, the graduation rate was 831 people, of which: 724-bachelor's degree, 107-master's degree. According to the SCPP as of 14.10.2020, employed (bachelor's degree) - 602(83%) of graduates, master's – 83 (77.5%). The total percentage of employment at the university was 82.4%.

Besides:

1. 9 graduates do master's degree (KRIU, MIEP) - Panihin Arthur, Sharikova Sophia, Utkaliev Kamilla, Balgazin Maksat - specialty "Jurisprudence", Novanov Islam, Boreychuk Galina -specialty "LSEP", Gasimov Miras – specialty "Management", Nysanov Damir-specialty "Philology", Sarsenov Isatay-specialty "Automation and control" i.e. 129 graduates belong to the category of the employed population.

2. According to the data of SI SCPP as of 14.10.2020, employment of graduates of the 2019-2020 specialty "Jurisprudence" is 75.5 %. The share of graduates of the 2019-2020 academic year is the specialty "Jurisprudence" -253 (bachelor's, master's), i.e. 31% of the total number of graduates. Of the 67 graduates, 41 graduates who do not have pension contributions are law enforcement officers, military personnel (except conscripts). On the basis of the Law of the Republic of Kazakhstan "On provision of pensions" dated 21.06.2013 №105-V (with amendments and additions as of 24.04.2019), military personnel (except conscripts), employees of special state and law enforcement agencies are exempt from paying mandatory pension contributions (article 24, paragraph 2, paragraph 3).

Thus, taking into account the above-mentioned category of citizens belonging to the category of the employed population on the basis of the Law of the Republic of Kazakhstan "On employment of the population" employment of graduates in 2020 as of 14.10.2020, amounted to 88.4%.
